Sub: **Telangana State Board of Intermediate Education (TSBIE) – certain applications received online for issuance of Equivalency certificates from TSBIE for other Boards – Fraud played by the candidates – Request to not act on fake certificates obtained in the name of Boards of Secondary / Higher secondary Education of other States. – regarding.**

It is to inform you that the TSBIE has received a complaint saying that several candidates had applied for equivalency certificates for their 12th class pass certificates issued by North West Accreditation Council, USA (NWAC) for the year 2015. As the NWAC was not recognized by the TSBIE, their applications for equivalency were rejected. The same candidates whose pass certificates from NWAC were rejected had re-applied for equivalency through TSBIE online services claiming that they have passed 12th class from Jammu & Kashmir Board of School Education.

In this regard, it is to inform you that, in Telangana state the TSBIE is the competent authority to decide whether the syllabus of various courses offered by different state Boards other than the TSBIE is equal to the syllabus of TSBIE or not. The TSBIE issues equivalency certificates to the examination of 12th class conducted by various boards established by the State Governments and also registered under Council of Boards of School Education (COBSE), New Delhi. The TSBIE does not vouch safe for the genuineness of the pass certificates issued though it certifies the Boards of other states. It is the responsibility of the college / institution where the student takes admission into Degree / Engineering / Medicine courses to verify the result and genuineness of the pass certificates submitted by the candidates. However in regard to certificates issued by TSBIE, we verify their genuineness.

It is also to inform you that, after receiving the complaint and on verification of the data available with TSBIE. It is found that about 84 candidates with 12th class pass certificates of J& K Board of School Education had applied for equivalency certificates from TSBIE and were issued equivalency certificates. It is also found that out of the above 84 candidates 12 candidates had already applied for equivalency certificates with NWAC certificates and after rejection of their applications again they applied pass certificates from Jammu & Kashmir Board. It will not be possible for any student to complete +2 education from two different Boards in the same academic year and it amounts to violation of academic rules. As TSBIE Hyderabad is a public office, on knowing the fraud committed it has lodged a police complaint at Begum Bazar Police Station, Hyderabad.

In this regard, you may like to inform all the Heads of Institutions under your jurisdiction to verify the results and genuineness of the pass certificates submitted by the candidates by sending their result particulars to the respective Boards before ratifying their admissions. A list of the recognized Boards is enclosed here with for kind perusal.
