Readmission:

The students who were detained in I / II /III / IV B.Tech I – Semester (JNTUH affiliated students) and detained in B.Tech / M.Tech I / III / V / VII – Semester (Autonomous students) due to shortage of attendance / Shortage of Credits are informed to note that the class work will be commencing in the month of July 2025 (for B,Tech III – Semester from 28.07.2025, for B.Tech V & VII – Semester from 21.07.2025 and for B.Tech/M.Tech I - Semester in July/ August 2025) for the academic year 2025-26. The students who are seeking for readmission are informed to complete the readmission process in Academic and Examination Section within one week from the commencement of class work to attend the classes.

Re-registration:

The students whose Continuous Internal Evaluation (CIE) Marks is less than 35 % of Continuous Internal Evaluation (CIE) Marks i.e less than 14 Marks out of 40 Marks in each course (Theory / Laboratory) for B.Tech and whose Continuous Internal Evaluation (CIE) Marks is less than 40 % of Continuous Internal Evaluation (CIE) Marks i.e less than 16 Marks out of 40 Marks in each course (Theory / Laboratory) for M.Tech in any course during B.Tech / M.Tech I or III-Semester are informed to re-register for such courses in Academic and Examination Section by paying requisite fee of Rs.3,000/- per course within 2 weeks from the commencement of class work and secure the required minimum attendance to re-appear for the Mid Term and external Examinations during the academic year 2025-26.
