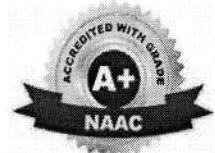

CIRCULAR

All Principals of the JNTUH Affiliated Autonomous Colleges hereby informed to note that following point for Challenge Valuation:

- (1) All Challenge Valuations (CV) will be done at Directorate of University Examinations (DUEX), JNTUH on payment of DD for an amount of Rs.10,000/- per subject per student in favour of the Registrar, JNTUH (A/c No.60279988622).
- (2) The paper will be evaluated at DUEX, JNTUH in the presence of senior faculty appointed by the Examination branch of the University and one subject expert/class teacher nominated by the students from his parent institute.
- (3) If there is any change in marks (Equal or above 15% of the maximum marks) the new marks will be awarded to the student. Otherwise, there will be no change in old marks.
- (4) If the change in marks (Equal or above 15% of the maximum marks) occurs, an amount of Rs.9,000/- will be refunded to the student. Otherwise the student will forfeit the total amount which he/she paid.
