The detailed Timetable will be released in due course. The practical examinations will be conducted before the theory examinations as per the academic calendar.

All the students appearing for the above mentioned examinations are required to download the examination application form along with the instructions for payment of Examination Fee (through **NEFT only**). The students have to register for the Examinations by submitting the filled in examination application form (separately for each semester) in the **Academic and Examinations Section (AES)** enclosing the Examination Fee receipt. It is reiterated that the students should pay the prescribed examination fee through **NEFT only** to Examination Fee Account: **MGIT COE SECTION**.

NOTE: Students should submit the filled in application form and payment receipt in the AES counter on the same day of payment of fee, without fail.

Instructions for Online mode of Payment of Examination Registration Fee

The students are advised to pay the examination fee through virtual mode using the details given below:

I. Online Transfer Mode:

Payment of examination fee from any bank shall be through Net Banking **NEFT only** involving the following steps: **(UPI/IMPS will not work)**

- Login into Internet banking
- Go to the Make payment mode (Banks require you to register the Beneficiary details for one time – please complete the process before effecting the payment).
- To add beneficiary:
 - Select manage payee
 - Add other Bank payee (**Note: Do not select ICICI Bank payee even if you are a ICICI bank user**)
 - Mention the Bank name as **ICICI Bank Ltd.**
 - Branch name (Not Mandatory): **CMS Mumbai (or) CMS New Delhi**
 - Enter Beneficiary Account Name: **MGIT COE Section**
 - Enter Beneficiary / Student Account Number: **MCOE** followed by HALL TICKET NUMBER (without space and without hyphen)

For example,

- If your Hall Ticket Number is **1234567890**, your Beneficiary / Student Account Number will be **MCOE1234567890**
- Confirm Payee Account Number (Beneficiary / Student Account Number)
 - Enter IFS code **ICIC0000104** (Note: The account name that will appear will be ICICI Bank, **CMS Mumbai or CMS New Delhi** as it is a Centralized Payment Solution)
 - Click on next page
 - Confirm payee (Beneficiary / Student Account Number) details and you will be receiving a URN number to your registered mobile. Enter the URN number and submit. Then Payee (Beneficiary / Student Account Number) will be added successfully.
 - Transfer the amount after 30 minutes to the added payee by **NEFT only**

II. Walk-in Mode:

- Walk in to Bank where you have an account
- Request for a NEFT form
- Mention the Bank Name as ICICI Bank Ltd.
- Mention the **Beneficiary Account Name** as “**MGIT COE Section**”
- Mention Type of Account as “**Savings Account**”
- Mention branch name as “**CMS Mumbai (or) CMS New Delhi**”
- Mention IFS code : **ICIC0000104**
- Mention Beneficiary / Student Account Number: **MCOE** followed by HALL TICKET NUMBER (without space and without hyphen)

For example,

If your Hall Ticket Number is **1234567890**, your Beneficiary /Student Account Number will be **MCOE1234567890**

- Fill the amount to be paid / transferred.
- Hand over the signed forms to the Bank official to initiate the payment.
